

No. 393. THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS II OF 1950 AND 31 OF 1951.

Bye-laws made by the Council of the Municipal Corporation of Kythrea.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Kythrea hereby make the following bye-laws :—

1. These bye-laws may be cited as the Municipal Corporation (Kythrea) (Amendment) Bye-laws, 1952, and shall be read as one with the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1950 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1952.

2. Paragraph 2 of the principal Bye-law 31 is hereby revoked and the following paragraph substituted therefor :—

"(2) The weight by which bread exposed for sale within the Municipal limits shall be sold, shall be as follows, that is to say :—

- (a) half kilogram ;
- (b) one kilogram."

3. The principal Bye-law 70 is hereby repealed and without prejudice to anything done or left undone thereunder it shall be deemed to have been repealed as from the 1st day of January, 1945.

4. The following bye-law shall be inserted immediately after the principal Bye-law 72 and shall be numbered as 72A :—

"72A. No person shall affix or cause to be affixed any hose, pipe or pump to any public fountain, spring, channel or pipe of the Kythrea Water Supply within the Municipal limits of Kythrea for the conveyance of water to any premises, factory, shop, mill, workshop, house, garden or land of any description or cause such water to be conveyed to such premises, factory, shop, mill, workshop, house, garden or land by any means whatsoever."

5. Bye-law 72A of the principal Bye-laws shall be re-numbered as 72AA.

6. The First Schedule immediately after the principal Bye-law 96 is hereby amended as follows :—

(a) by the repeal of item 27 and the substitution therefor of the following :—

" Item No.	Goods.	Minimum weight. okes	Fees.
27. Lime		40 ..	6p. per ton 3p. per $\frac{1}{2}$ ton 1 $\frac{1}{2}$ p. per $\frac{1}{4}$ ton."

(b) by the substitution of the following item 27A immediately after item 27 :—

" Item No.	Goods.	Minimum weight. okes	Fees.
27A. Limestone, whether in its natural state or cut to pieces or ground		40 ..	5p. per ton or part thereof."

The above Bye-laws have been approved by His Excellency the Governor.
