#### **ORDER**

1. This Order may be cited as the -

## COMMONWEALTH OF DOMINICA DISNEY MICKEY THROUGH THE YEARS COMMEMORATIVE ISSUE STAMP ORDER 1997.

- 2. In this Order the term "Stamps" means an adhesive stamp Interpretation. for postage and revenue.
- 3. During the period from 15th April, 1997 to 14th July, 1997, Stamps. both days inclusive, there shall be issued throughout the State special Commonwealth of Dominica postage stamps (DISNEY MICKEY THROUGH THE YEARS COMMEMORATIVE STAMP ISSUE) of the values and colours specified in Schedule I. Schedule II.
- **4.** The dies and other implements required to give effect to Dies this Order shall be destroyed with all residue whatsoever of all stamps authorised hereby as soon as possible after the 14th day of July, 1997.
- 5. This Order shall be deemed to have come into force on the Commencement. 15th day of April, 1997.
