### LAW REVISION (OMISSION OF ACTS) ORDER 1991.

- 2. (1) The Commission is authorised to omit from the Laws of Omission of Dominica the Acts set out in the Schedule and any enactments Acts.

- (2) For the purposes of this section "Laws of Dominica" means the 1990 Revised Edition of the Laws of Dominica.
- 3. The Acts authorised to be omitted by this Order comprise the Types of Acts following:
  - (a) Enactments relating to property rights.
  - (b) Validations.
  - (c) Tax Exemptions.
  - (d) Temporary Acts.
  - (e) Individual Pensions Acts.
  - (f) Incorporations (Private Acts).
  - (g) Enactments Schedules for -
    - (i) repeals; or
    - (ii) repeal and replacement.
