ORDER

**MADE by the Minister under section 7 of the Magistrate's Code of
Procedure Act, (Chap. 4:20).**

1. This Order may be cited as the –

Short title.

**MAGISTRATES' COURTS DISTRICTS (AMENDMENT)
ORDER 1995.**

**2. In this Order the Magistrates' Courts Districts Order is re-
ferred to as "the Principal Order".**

**Interpretation.

3. Section 3 of the Principal Order is replaced as follows:

"Sitting of courts.

**3. The Magistrates' Courts of Districts "E", "F"
and "G" shall be held from nine a.m. or such other
hour as the Chief Magistrate may appoint on the
days and at the places shown hereunder –**

(1) DISTRICT "E" –

**(a) At the ground floor of the premises
known as the High Court and Regis-
try Building, Bay Front, Roseau, on
every working day of the week as
may be expedient with a magistrate
presiding in each court.**

- (b) At the Police Station, St. Joseph, on every Wednesday and Thursday and on such other day or days as may seem fit to the Chief Magistrate.

(2) DISTRICT "F" –

- (a) At the Police Station, Grand Bay, situated on the public road leading to the Centre, in the Parish of St. Patrick erected on land containing 12,786 square feet and bounded as follows:

NORTH-EAST : By Government lands;

NORTH-WEST: By Public Road;

SOUTH-EAST : By Government lands;

SOUTH-WEST: By Government lands;

on every Monday and Tuesday except the first Tuesday of every month, and on such other day or days as may seem fit to the Chief Magistrate.

- (b) At the Police Station, Delices, in the Parish of St. Patrick erected on land containing 20,309 square feet and bounded as follows:

NORTH: By the Government Health Centre;

SOUTH: By lands of Anthony Sorhaindo;

EAST : By lands of Anthony Sorhaindo;

WEST : By lands of Mrs. Juliana
St. Jean,

on the second Friday of every month.

- (c) In the building that previously housed the Dental Auxiliary and Environmental Health Offices situated on Government land in the village of La Plaine and bounded as follows:

NORTH: By Government lands;

EAST : By the Public Road;

SOUTH : By the La Plaine Police Station;

WEST : By Government lands,
on every first Tuesday and fourth Friday and on such other day or days as may seem fit to the Chief Magistrate.

- (d) At the one-storey concrete building known as the Police Station, Castle Bruce, erected on Government land purchased from the Commonwealth Development Corporation (formerly known as the Colonial Development Corporation) containing 1.06 acres and bounded as follows:

NORTH : By lands of His Lordship the Bishop of Roseau and the Public Road;

SOUTH AND SOUTH-WEST : By lands of Castle Bruce Estate;
