An Act to impose, as taxes, fees for things done under the *Business Names Registration Act 2011*, and for related purposes

1 Short title

This Act may be cited as the Business Names Registration (Fees) Act 2011.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.
