NATIONAL ECONOMIC AND SOCIAL DEVELOPMENT OFFICE ACT 2006

AN ACT TO MAKE PROVISION FOR THE ESTABLISHMENT OF A BODY TO BE KNOWN AS THE NATIONAL ECON-OMIC AND SOCIAL DEVELOPMENT OFFICE COMPRIS-THREE BODIES TO BE KNOWN ING AS THE NATIONAL ECONOMIC AND SOCIAL COUNCIL, THE NATIONAL ECONOMIC AND SOCIAL FORUM, THE NATIONAL CENTRE FOR PARTNERSHIP AND PER-FORMANCE, AND SUCH OTHER BODIES AS THE TAOISEACH MAY BY ORDER ESTABLISH AND TO DEFINE THEIR FUNCTIONS AND TO DISSOLVE THE NATIONAL ECONOMIC AND SOCIAL COUNCIL, THE NATIONAL ECONOMIC AND SOCIAL FORUM AND THE NATIONAL CENTRE FOR PARTNERSHIP AND PERFORMANCE, AND TO PROVIDE FOR RELATED MATTERS.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

PART 1

PRELIMINARY AND GENERAL

1.—This Act may be cited as the National Economic and Social Short title. Development Office Act 2006.

2.—In this Act— Definitions.

- "body" means a body established by or under this Act;
- "Centre" means National Centre for Partnership and Performance established by *section* 6(2);
- "Chief Officer" means the chief officer of the Office;
- "Council" means National Economic and Social Council established by section 6(2);
- "Director" means the director of a body (other than the Office);
