#### CENTRAL BANK AND FINANCIAL SERVICES **AUTHORITY OF IRELAND ACT 2004**

AN ACT TO AMEND THE CENTRAL BANK ACT 1942 FOR THE PURPOSES OF ESTABLISHING THE FINANCIAL SERVICES OMBUDSMAN'S BUREAU AND PRESCRIB-ING THE FUNCTIONS AND POWERS OF THAT OMBUDSMAN, PROVIDING FOR THE ESTABLISH-MENT OF CONSULTATIVE PANELS TO ADVISE THE IRISH FINANCIAL SERVICES REGULATORY AUTH-ORITY ON CERTAIN MATTERS; TO AMEND THE CEN-TRAL BANK ACT 1997 FOR THE PURPOSES OF MAK-ING FURTHER PROVISION FOR AUDITING THE ACCOUNTS OF FINANCIAL SERVICE PROVIDERS AND PROVIDING FOR THE REGULATION OF MONEY TRANSMISSION BUSINESSES; AND TO MAKE MIS-CELLANEOUS AMENDMENTS TO CERTAIN OTHER ACTS AND STATUTORY INSTRUMENTS RELATING TO THE PROVISION OF FINANCIAL SERVICES.

### BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

#### PART 1

#### **PRELIMINARY**

- 1.—(1) This Act may be cited as the Central Bank and Financial Short title and Services Authority of Ireland Act 2004.
- (2) This Act comes into operation on such day or days as may be fixed by an order or orders made by the Minister for Finance, either generally or with reference to any particular purpose or provision. Different days may be fixed for different purposes and different provisions.
