THE PORT AUTHORITY (COMPULSORY TOWAGE) (HARBOUR OF KINGSTON) DIRECTIONS, 1994

(Made by the Authority on the 2nd day of September, 1994)

1. These Directions may be cited as the Port Authority (Compulsory Towage) (Harbour of Kingston) Directions, 1994.

2.—(1) For the purposes of safe navigation, movement and berthing of vessels in the Harbour of Kingston, every person who navigātes a vessel (other than an excepted ship) in the Harbour of Kingston shall—

- (a) during such navigation use the towage services provided by the Authority; and
- (b) pay such towage fees as the Authority may determine (which fees are payable even if the services provided have not been used).

(2) In paragraph (1) "excepted ship" has the same meaning as under the Pilotage Act.

BY-LAWS (under section 11)

THE PORT AUTHORITY (REGULATIONS OF CRUISE SHIP PREMISES) **By-Laws**, 2001

(Made by the Authority on the 14th day of September, 2001)

1. These By-Laws may be cited as the Port Authority (Regulation of Citation. Cruise Ship Premises) By-Laws, 2001.

- 2. In these By-Laws-
 - "Port Authority premises" means all cruise ship premises vested in, owned or controlled by the Port Authority;
 - "Tourist Board" means the Tourist Board established under the Tourist Board Act.

3.-(1) No person shall operate or maintain any business on Port Authority premises unless such person is the holder of a licence issued by the Port Authority Authority for the purpose.

(2) The Authority may in its discretion refuse to grant or renew a licence to operate any business under these By-Laws.

4.—(1) The Authority may—

- (a) give notice in writing to a licensee suspending his licence for such period as the Authority may consider necessary or desirable; or
- (b) revoke the licence with effect from such date as the Authority specifies in the notice.

(2) All rights and privileges enjoyed under any licence which is revoked or suspended hereunder shall cease to have effect from the date specified in the notice of revocation or suspension as the case may be, but such revocation or suspension shall not in any way affect the liability of the licensee or other person in respect of contravention of these By-Laws or breach of the terms of the licence that may have occurred prior to that revocation or suspension.

Tourist Board permits to taxi and contract car operators. 5. No person shall on any Port Authority premises engage in activities as a taxi operator or contract carriage operator unless—

- (a) he is the holder of a valid permit issued by the Tourist Board or by such other body as may be approved by the Port Authority; and
- (b) such activities are carried out in accordance with the terms and conditions of the permit,

6.—(1) The Authority may from time to time appoint such persons as it considers suitable to be inspectors for the purposes of these By-Laws.

(2) An inspector appointed under paragraph (1) may at all reasonable times inspect any business being conducted on the Port Authority premises to ensure that the provisions of these By-Laws are being complied with.

Conduct and attire.

- 7. Every person entering or using the Port Authority's premises shall-
 - (a) have a valid identification which is acceptable to the Authority and exhibit such 1D at the request of the Authority or its agents;
 - (b) conduct himself in an orderly manner and shall be decently attired.

8. No person shall enter or leave any Port Authority premises otherwise than through the gates, passages or openings appointed for the purpose by the Authority.

9. No person shall be on any Port Authority premises except with the permission of an authorized officer of the Authority.

10. Every person shall obey all directions issued by the Authority to regulate the routing of motor vehicles or other vehicles through the Port Authority premises.

11. No person shall, while on Port Authority premises—

- (a) sell or distribute or expose for sale, any goods, wares, merchandise or animal;
- (b) make, dress or paint any article or material;
- (c) use any threatening or abusive language;
- (d) conduct himself in an unseemly or disorderly manner or in such a way as to provoke a breach of the peace;
