1. This Order may be cited as the Technical Assistance (Immunities and Privileges) (International Institute of Tropical Agriculture) Order, 1986.

2. The International Institute of Tropical Agriculture, hereinafter referred to as the approved organization, is hereby declared to be a foreign organization providing technical assistance to Jamaica.

3. For the purposes of the Act—

- (a) the approved organization shall have all the immunities and privileges set out in Part I of the Schedule to the Act; and
- (b) representatives and experts and their families and staff of the approved organization shall have all the immunities and privileges specified in Part II of the Schedule to the Act.

1. This Order may be cited as the Technical Assistance (Immunities and Privileges) (The Friedrich Ebert Stiftung and Konrad Adenauer Stiftung Foundations) Order, 1987.
2. The Friedrich Ebert Stiftung and Konrad Adenauer Stiftung Foundations, hereinafter referred to as the approved organizations, are hereby declared to be foreign organizations providing technical assistance to Jamaica.
3. For the purposes of the Act, the approved organizations shall have all the immunities and privileges set out in Part I of the Schedule to the Act.

THE TECHNICAL ASSISTANCE (IMMUNITIES AND PRIVILEGES) (FEDERAL
REPUBLIC OF GERMANY) ORDER, 1984

(Made by the Minister on the 17th day of July, 1984)

L.N. 173/84

1. This Order may be cited as the Technical Assistance (Immunities and Privileges) (Federal Republic of Germany) Order, 1984.

2. The Federal Republic of Germany, hereinafter referred to as the approved government, is hereby declared to be a foreign government providing technical assistance to Jamaica.

3. For the purposes of the Act—

- (a) the approved government shall have all the immunities and privileges set out in Part I of the Schedule to the Act, including, without prejudice to the generality of the foregoing, the exemption from customs duties provided for in paragraph 1 of that Part; and
- (b) experts of the approved government shall have all the immunities and privileges specified in Part II of the Schedule to the Act.

4. In addition to the immunities and privileges referred to in paragraph 3 there is also conferred—

- (a) on the approved government, exemption from taxes, rates, dues and charges (other than customs duties) relating to the items referred to in paragraph 1 of Part I of the Schedule to the Act; and

- (b) on experts of the approved government, exemption from income tax and other fiscal charges in respect of any emoluments paid to them by the authorities of the approved government.
