BERNAMA ACT 1967

An Act to establish and incorporate the Pertubuhan Berita Nasional Malaysia, and to provide for the management and supervision of the Pertubuhan Berita Nasional Malaysia and other matters connected therewith.

[6 April 1967]

PART I

PRELIMINARY

Short title and application

- 1. (1) This Act may be cited as the BERNAMA Act 1967.
 - (2) This Act applies throughout Malaysia.

Interpretation

- 2. In this Act, unless the context otherwise requires—
- "BERNAMA" means the Pertubuhan Berita Nasional Malaysia as established under subsection 3(1);
- "Board" means the Board of Governors of BERNAMA appointed under section 7;
- "news or news material" includes international, regional and national—
 - (a) news;
