An Act to provide for the establishment of a body corporate by the name of the Malaysia External Trade Development Corporation, and other matters connected therewith.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

PART I

PRELIMINARY

1. This Act may be cited as the Malaysia External Short title Trade Development Corporation Act 1992 and shall and commencement. come into force on such date as the Minister may, by notification in the Gazette, appoint.

2. In this Act, unless the context otherwise requires— Interpretation.

"Chairman" means the Chairman of the Corporation appointed under section 4;

"Chief Executive Officer" means the Chief Executive Officer of the Corporation appointed under section 20 and includes any officer directed under section 21(4) to perform the duties of the Chief Executive Officer;

"committee" means a committee of the Corporation appointed under section 17;

"company" has the same meaning as that assigned to "corporation" under section 4(1) of the Companies Act Act 125. 1965;
