AKTA IMIGRESEN 1959/63

PERATURAN-PERATURAN IMIGRESEN (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 54 Akta Imigresen 1959/63 [*Akta 155*], Menteri, dengan persetujuan Ketua Menteri Sabah dan Sarawak, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Imigresen (Pindaan) 2022**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 16 Mac 2022.

Pindaan Jadual Ketiga

2. Peraturan-Peraturan Imigresen 1963 [L.N. 228/1963], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam Jadual Ketiga—

(a) dalam butiran V—

(i) dengan mengantikan subbutiran (vii) dengan subbutiran yang berikut:

"(vii) For any non-Malaysian citizen permitted by the Government to join the retirement programme or Malaysia as a second home programme (a) RM500.00 per year or part of a year for an application fee (b) RM5000.00 per issuance for a processing fee"; dan

(ii) dengan memasukkan selepas subbutiran (vii) subbutiran yang berikut:

“(viiia) For the dependant (a) RM500.00 per year or part of the holder of Visit Pass issued to a non-Malaysian citizen permitted by the Government to join the retirement programme or Malaysia as a second home programme (b) RM2500.00 per issuance for a processing fee”; dan

(b) dalam butiran VIII—

(i) dengan memotong perkataan “and” di hujung subbutiran (a); dan
(ii) dengan memasukkan selepas subbutiran (a) subbutiran yang berikut:

“(aa) a processing fee for any Visit Pass issued to a non-Malaysian citizen permitted by the Government to join the retirement programme or Malaysia as a second home programme in Sabah or Sarawak;

(ab) a processing fee for any Visit Pass issued to the dependant of the holder of Visit Pass issued to a non-Malaysian citizen permitted by the Government to join the retirement programme or Malaysia as a second home programme in Sabah or Sarawak; and”.
