AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN PEMINDAHAN) 2014

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Pemindahan) 2014**.

(2) Perintah ini mula berkuat kuasa pada 27 Januari 2014.

Larangan pemindahan

2. (1) Melainkan jika dibenarkan oleh Ketua Pengarah Kastam, pemindahan barang yang dinyatakan dalam ruang (1) dan (2) Jadual Pertama, di antara Semenanjung Malaysia, Sabah dan Sarawak, adalah dilarang.

(2) Melainkan jika dibenarkan oleh pihak berkuasa berkaitan yang dinyatakan dalam ruang (3) Jadual Kedua, pemindahan barang yang dinyatakan dalam ruang (1) dan (2) Jadual Kedua, di antara Semenanjung Malaysia, Sabah dan Sarawak, adalah dilarang.

Pembatalan

3. Perintah Kastam (Sekatan Penggerakan) 2000 [*P.U. (A) 476/2000*] dibatalkan.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF REMOVAL) ORDER 2014

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Removal) Order 2014**.

(2) This Order comes into operation on 27 January 2014.

Prohibition of removal

2. (1) Unless permitted by the Director General of Customs, the removal of the goods specified in columns (1) and (2) of the First Schedule, between Peninsular Malaysia, Sabah and Sarawak, is prohibited .

(2) Unless permitted by the relevant authority specified in column (3) of the Second Schedule, the removal of the goods specified in columns (1) and (2) of the Second Schedule, between Peninsular Malaysia, Sabah and Sarawak, is prohibited.

Revocation

3. The Customs (Restriction of Movements) Order 2000 [*P.U. (A) 476/2000*] is revoked.
