PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) (NO. 2) 2013

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) (No. 2) 2013**.

(2) Perintah ini mula berkuat kuasa pada 23 Julai 2013.

(4)	Waste, parings and scrap of rubber (other than hard rubber) and powders and granules obtained therefrom	40.04
