AN ACT to provide for the implementation of the Compact of Free Association, as Amended, by giving it the force and effect of law.

**§101. Short title.**

This Chapter may be cited as the Compact of Free Association, as Amended (Implementation) Act, 2004. [P.L. 2004-01, §1.]

**§102. Interpretation.**

In this Chapter, “**the Compact, as Amended**” means the Compact of Free Association, as Amended, and its subsidiary agreements concluded with the Government of the United States on April 30, 2003 as its implementation is affected by the Compact of Free Association Amendments Act of 2003. **§103. Implementation of the Compact, as Amended.**

(1) Subject to the provisions of the Compact of Free Association, as Amended Resolution 2004, and this Act, the Compact of Free Association, as Amended shall have the force and effect of law as if enacted by the Nitijela .
