#### PASSPORT ACT, 2020

**AN ACT** to provide for the Regulation of the Passports application and issuance process; the establishment of the Division of Passports and Citizenship, the Passport Review Penal; the functions and powers of the Director and the Panel; the authority of the Attorney General; establishment of the Passport application process, and the attending requirements; the application review process; the approval and issuance of Passports; the creation of prohibitions; establishment of offenses and penalties; and for related matters.

#### PART I - PRELIMINARY

#### §1101. Short title.

This Act may be cited as Passport Act, 2020.

### §1102. Interpretation.

Unless the context determines otherwise, the following terms and phrases shall have the following meaning:

- (a) 'Attorney General' means the Attorney General of the Republic of the Marshall Islands or his/her designee;
- (b) 'Cabinet Minute' means the official record of a Cabinet decision maintained by the Clerk of Cabinet;
