### THE QUAID-E-AZAM UNIVERSITY ACT, 1973.

#### An Act to reconstitute and reorganize the University of Islamabad.

WHEREAS it is expedient to reconstitute and reorganize the University of Islamabad for the purpose of improving its administration;

It is hereby enacted as follows:—

- 1. Short title and commencement.—(1) This Act may be called the <sup>2</sup>[Quaid-e-Azam University Act, 1973].
  - (2) It shall come into force at once.
  - **2. Definitions.** In this Act, unless there is anything repugnant in the subject or context,—
    - (a) "Academic Council" means the Academic Council of the University;
    - <sup>3</sup>[(aa) "affiliated college" means an educational institution affiliated to, but not maintained or administered by, the University;]
    - **(b)** "Authority" means an Authority of the University specified in section 18;
    - (c) "Chancellor" means the Chancellor of the University;
    - <sup>3</sup>[(cc) "College" means a constituent college or an affiliated college;]
    - (d) "constituent college " means a college maintained and administered by the University;
    - (e) "Dean" means the Chairman of the Board of a Faculty;
    - (f) "Director" means the head of an Institute;
    - **(g)** "educational institution" means an institution imparting instruction in a subject or subjects relating to a Faculty;
    - (h) "Faculty" means a Faculty of the University;
    - (i) "Government" means the Federal Government;
    - (i) "Institute" means a constituent institute maintained and administered by the University;

1\* (n) "Vice-Chancellor" means the Vice-Chancellor of the University; (o) "Registered graduate" means a graduate of the University who has his name entered in the register maintained for the purpose; 3\* (q) "Statutes", "Regulations" and "Rules" means the Statutes, Regulations and Rules made or deemed to have been made under this Act and for the time being in force; (r) "Syndicate" means the Syndicate of the University; (s) "Teachers" include Professors, Associate Professors, Assistant Professors and Lecturers engaged whole-time by the University or by a constituent college for teaching honours or post-graduate classes, and such other persons as may be declared to be Teachers by the Regulations; (t) "Teaching Department" means a teaching department maintained and administred or recognized by the University; <sup>4</sup>[(u) "University" means the Quaid-e-Azam University as renamed under this Act;] (v) "University Teacher" means a whole-time Teacher appointed and paid by the University,

(k) "prescribed" means prescribed by Statutes, Regulations or Rules;

(m) "Pro-Chancellor" means the Pro-Chancellor of the University;

(I) "Principal" means the head of a 1\* \* \* college;

#### **CHAPTER II**

#### THE UNIVERSITY

**3. Incorporation.**—<sup>5</sup>[(1) The University of Islamabad as reconstituted in accordance with the provisions of this Act and having its principal seat at Islamabad shall, on and from the commencement of the University of Islamabad (Amendment) Act, 1976 (XIV of 1976), be renamed as 'the Quaid-e-Azam University'.]
