[REPUBLIC ACT NO. 2208, May 15, 1959]

AN ACT TO PROVIDE ONE ADDITIONAL ASSISTANT PROVINCIAL FISCAL FOR THE PROVINCE OF SAMAR, AMENDING FOR THE PURPOSE SECTION SIXTEEN HUNDRED SEVENTY-FOUR OF THE ADMINISTRATIVE CODE, AS AMENDED.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section sixteen hundred seventy-four of the Administrative Code, as amended by Republic Act Numbered Seventeen hundred ninety-nine, is further amended to read as follows:

"SEC. 1674. Assistant Provincial Fiscals.—In the folding provinces there shall be assistant provincial fiscals in such numbers as are hereinafter provided:
