

[TESDA RESOLUTION NO. 2010-01, April 08, 2010]

**APPROVING THE AMENDMENTS TO THE TRAINING
REGULATIONS FOR DENTAL LABORATORY TECHNOLOGY
SERVICES (REMOVABLE DENTURES/APPLIANCES) NC II AND
DENTAL LABORATORY SERVICES (FIXED
DENTURES/RESTORATION) NC II**

WHEREAS, Board Resolution No. 2008-04 was issued by the Board the Training Regulations for Dental Laboratory Technology Services NCI, Dental Laboratory Technology Services (Fixed Dentures/Restoration) NC II, and *Dental Laboratory Technology Services (Removable Dentures/Appliances)* on 11 April 2008 during the 60th TESDA Board Meeting;

WHEREAS, during the 42nd Standards-Setting and Systems Development (SSSD)-TESDA Board-TESDA Secretariat Committee Meeting held last 21 December 2009, the Committee favorably endorsed the amendments to the Training Regulations for Dental Laboratory Technology Services (Removable Dentures/Appliances) NCII and Dental Laboratory Technology Services (Fixed Dentures/Restoration) NCII as attached hereto;

WHEREAS, during the 71st EXCOM-TESDA Board Meeting on 11 March 2010, the Standards-Setting and Systems Development (SSSD) Committee agreed to recommend for approval the aforesaid amendments to the Training Regulations for Dental Laboratory Services (Removable Dentures/ Appliances) NCII and Dental Laboratory Technology Services (Fixed Dentures/Restoration) NCII;

WHEREAS, the amended partTESDA RESOL* of the aforesaid Training Regulations are herewith annexed and made an integral part of this resolution;

WHEREAS, in the 74th TESDA Board Meeting on 8 April 2010 at 3:00 p.m., the TESDA Board considered and approved the amendments to the Training Regulations for Dental Laboratory Technology Services (Removable Dentures/Appliances) NCII and Dental Laboratory Services (Fixed Dentures/Restoration) NCII;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 8 April 2010, 3:00 p.m., approves the aforementioned amendments to the Training Regulations for Dental Laboratory Technology Services (Removable/Dentures/Appliances) NCII and Dental Laboratory Services (Fixed Dentures/ Restoration) NCII;

BE IT RESOLVED FINALLY, that copies of this Resolution and Training Regulations be published and disseminated to all concerned, and the same shall be effective fifteen (15) days upon publication. All programs registered under these training regulations must comply with the requirements of the aforementioned training
