ADDENDUM TO MEMORANDUM CIRCULAR NO 763-2006 – LETAS SETTLE ANYWHERE

To effectively implement the objectives of MC No. 763-2006 and for customer satisfaction, the following violations that do not require presentation of evidence and suspension of driver's licenses, are included in the LETAS Settle Anywhere Policy:

1. Sec. 1 – DRIVING WITHOUT A LICENSE
2. Sec. 2A – DRIVING WITH DELINQUENT OR EXPIRED LICENSE
3. Sec. 2B – DRIVING WITH SUSPENDED OR REVOKED OR IMPROPER LICENSE
4. Sec. 3A – FAILURE TO SHOW OR SURRENDER LICENSE
5. Sec. 3B – FAILURE TO CARRY DRIVER'S LICENSE
6. Sec. 3C – FAILURE TO SIGN DRIVER'S LICENSE
7. Sec. 9 – A STUDENT DRIVER OPERATING MV WITHOUT BEING ACCOMPANIED BY A LICENSED DRIVER
8. Sec. 10 – UNLICENSED CONDUCTOR
9. Sec. 10A – FAILURE TO WEAR THE PRESCRIBED SEAT BELT DEVICES AND/OR FAILURE TO REQUIRE HIS PASSENGERS TO WEAR THE PRESCRIBED SEAT BELT DEVICE OR TO TAKE ANOTHER SEAT FOR WHICH A SEAT BELT IS NOT REQUIRED

10. Sec. 33 – NO EWD OR FAILURE TO USE EARLY WARNING DEVICE
11. Sec. 33B – FAILURE TO INSTALL EWD 4 METERS AWAY TO THE FRONT AND REAR OF THE STALLED/DISABLED MV
12. Sec. 57 – USE OF SLIPPERS OR SLEEVELESS SHIRTS WHEN
(1st Offense) DRIVING A 'FOR HIRE' VEHICLE
13. Sec. A – NO ID DISPLAYED
14. Sec. D – INSUFFICIENT CANVASS COVER/NO CANVASS COVER (CIRCULAR 12)
15. Sec. L – TRICYCLE IN THE HIGHWAY – TRICYCLE BAN ALONG NATIONAL HIGHWAY
16. Sec. T02 – TRUCK BAN
17. Sec. T26 – DISREGARDING TRAFFIC OFFICER (DTO)
