CREATING AND DESIGNATING A BUILDING WHICH STANDS ON A LAND LOCATED AT BLOCK 2, 32 nd STREET CORNER 9 th AVENUE, BONIFACIO GLOBAL CITY, TAGUIG CITY, AS AN INFORMATION TECHNOLOGY CENTER, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748
