

**[ PROCLAMATION No. 1507, May 09, 2008 ]**

**DECLARING A PARCEL OF LAND OF THE PUBLIC DOMAIN FOR PUBLIC BEACH AND ECO-TOURISM PURPOSES LOCATED ALONG THE COAST OF "PUNTA" BARANGAY POBLACION, MUNICIPALITY OF ZAMBOANGUITA, PROVINCE OF NEGROS ORIENTAL**

Pursuant to the powers vested in me by the law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby declare certain parcel of land of the public domain located along the coast of "Punta", Barangay Poblacion, Municipality of Zamboanguita, Province of Negros Oriental for Public Beach and Eco-Tourism purposes under the administration of the Local Government of the Municipality of Zamboanguita, Province of Negros Oriental, subject to final ground survey and private rights, if any there be, which parcel of land more particularly described as follows"

"A parcel of land, situated in Barangay Poblacion, Municipality of Zamboanguita, Province of Negros Oriental"

Beginning at a point marked "1" on the plan being S. 50-07'W., 982.79 meters from B.L.L.M. No. 1, Pls-847, Zamboanguita, Negros Oriental, thence:
