

[PROCLAMATION NO. 1180, November 30, 2006]

**CREATING AND DESIGNATING A PROPOSED BUILDING, TO BE
KNOWN AS THE SYNERGIS IT CENTER, WHICH WILL BE
ESTABLISHED ON A LOT LOCATED AT F. CABAUG STREET,
BARANGAY KASAMBAGAN, CEBU CITY AS INFORMATION
TECHNOLOGY CENTER, PURSUANT TO REPUBLIC ACT NO. 7916
AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority, **I, GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, do hereby create and designate as **Information Technology Center**, subject to the provisions of Republic Act No. 7916, as amended, its Implementing Rules and Regulations and Resolutions Nos. 00-411 and 06-301 dated 29 December 2000 and 11 July 2006, respectively, of the Board of Directors of the Philippine Economic Zone Authority (PEZA), the Synergis IT Center, which will be established on a lot located at F. Cabahug Street, Barangay Kasambagan, Cebu City, containing an area of **Four Thousand Five Hundred Eighty Seven (4,587) square meters**, more or less, as defined by the following technical descriptions:

Lot 710-D Psd-07-065846

A parcel of land (Lot 710-D, Psd 07-065846, being a portion of Lot 710, Banilad Estate) situated in the Barrio of Kasambagan, City of Cebu, Island of Cebu. Bounded on the N.W., along line 1-2 by Lot-710-A, on the N.E, along line 2-3 by Lot-710-C, both of the subdivision plan; on the S.E., along line 3-4 by Lot-706; on the S.W., along line 4-5 by Lot-709; on the N.W., along line 5-1 by Lot-711, all of Banilad Estate.

Beginning at a point marked "1" on plan, being N. 57 deg. 03' E., 853.1.3 m. from Mon. no. 3, Banilad Estate,

All points referred to are Indicated on the plan and are marked on the ground as follows; points 4 and 5 by Old P.S. Cyl. conc. mon. 15 x 60 cms., and the rest by P.S. Cyl. conc, mons, 15 x 40 cms. Bearings true. Date of original survey, August 1906 to July 1907 and that the subdivision survey executed by Geodetic Engineer Norvic S. Abella, on February 11, 2006 and was approved on July 20, 2006.
