

[PROCLAMATION NO. 1193, December 11, 2006]

**AMENDING PROCLAMATION NO. 848 DATED JANUARY 14, 1992,
WHICH TRANSFERRED TO THE NATIONAL HOUSING AUTHORITY
THE ADMINISTRATION AND DISPOSITION OF THE LAND
LOCATED IN PUNTA, STA. ANA, MANILA RESERVED FOR
RELOCATION SITE PURPOSES UNDER PROCLAMATION NO. 687
SERIES OF 1960, SY TRANSFERRING THE MANAGEMENT AND
ADMINISTRATION OF A PORTION OF THE LAND EMBRACED
THEREIN TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL
RESOURCES (DENR)**

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby amend Proclamation No. 848 dated January 14, 1992 which transferred to the National Housing Authority the administration and disposition of the land located in Punta, Sta. Ana, Manila reserved for relocation site purposes under Proclamation No. 687 Series of 1960 by transferring the management and administration of a portion of the land embraced therein to the Department of Environment and Natural Resources (DENR), subject to actual survey, which parcel of land is more particularly described as follows:

TECHNICAL DESCRIPTION

A parcel of land titled in the name of the Republic of the Philippines under Transfer Certificate of Title (TCT) No. 142111 commonly known as the J. Posadas Residential Subdivision situated in the District of Sta. Ana, City of Manila, Island of Luzon.

Bounded on the NE., points 9 to 12 by Lot 3; points 12 to 13 by Lot 2; points 13 to 15 by Lot 1, all of Block 3, (LRC) Pcs-193 points 16 to 17 by Lot 2, Rs-264; and points 17 to 20 by property of Philippine Match Co. Ltd.; in the SE., points 20 to 31 by Lot 5, Block 1, Rs-264, Swo-18237) property of Gregorio Araneta, Inc.; points 1 to 2 by Lot 6-B-2-B, Psd-32211, property of Marcelo Steel Corporation; on the SW., points 31 to 33 by Lot 6-B-1, Block 1, Swo-18237, property of Gregorio Araneta, Inc.; points 33 to 1 by Lot 1-B-2-B, Psd-32211, property of Meralco Steel Corporation; points 2 to 4 by Lot 1, Pcs-3493, property of the Republic of the Philippines; and on the NW., points 4 to 9 by Pasig River.

Beginning at a point marked "1" on plan, being N. 51 deg. 44' W., 616.68 m. from Sta. Ana Church Spire, thence:
