AMENDING EXECUTIVE ORDER NO 46 DATED MAY 28, 1908, BY SEGREGATING A CERTAIN PORTION OF LAND OF THE PUBLIC DOMAIN LOCATED IN BARANGAY LIWANAG, PUERTO PRINCESA CITY, PALAWAN AND RESERVING THE SAME FOR HOUSING SITE PURPOSES AND DECLARING THE SAME OPEN FOR DISPOSITION UNDER THE PROVISIONS OF THE URBAN DEVELOPMENT AND HOUSING ACT (REPUBLIC ACT NO. 7279)

Upon the recommendation of the Secretary of Environment and Natural Resources, and pursuant to the powers vested in me by law, **I, GLORIA MACAPAGAL** – **ARROYO**, President of the Republic of the Philippines, do hereby amend Executive Order No. 46 dated May 28, 1908, which reserved certain parcels of land of the public domain located in Barangay Liwanag, Puerto Princesa City, Palawan for provincial building and school sites purposes, by excluding a portion of the land embraced therein and declaring the same open for disposition for housing site purposes in favor of the qualified occupants/beneficiaries pursuant to the provisions of the Urban Development and Housing Act of 1992 (Republic Act No. 7279), subject to private rights, if any there be, and to final survey, which area is more particularly described as follows:
