

[PROCLAMATION NO. 146, August 06, 1963]

**REVOKING PROCLAMATION NO. 11, DATED FEBRUARY 21, 1924,
WHICH RESERVED FOR MILITARY PURPOSES CERTAIN PARCELS
OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE
MUNICIPALITY OF PANTUKAN, PROVINCE OF DAVAO, ISLAND
OF MINDANAO, AND RESERVING THE SAME FOR MARKET SITE
PURPOSES**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the authority vested in me by law, I, Diosdado Macapagal, President, of the Philippines, do hereby revoke Proclamation No. 11, dated February 21, 1924, which reserved for military purposes certain parcels of land of the public domain situated in the Municipality of Pantukan, Province of Davao, Island of Mindanao, and reserve the same for market site purposes under the administration of the said Municipality of Pantukan, subject to private rights, if any there be, which parcels of land are more particularly described as follows:

Lot 276
Pantukan Cadastre, Case I

A parcel of land (Lot 276 of the cadastral survey of Pantukan, L.R.C. Cad. Record No. ———), situated in the municipality of Pantukan, Province of Davao. Bounded on the E., along line 1-2, by Lot 273; on the S., along line 2-3, by Lot 1831, on the W., along line 3-4, by Lot 1561; and on the N., along line 4-1, by Lot 273, all of Pantukan, Cad. Beginning at a point marked 1 on plan, being N. 84° 51' W., 348.56 meters from B.L.L.M. 2, Pantukan. Cad., thence S. 3° 22' 33., 63.01 meters to point 2; thence S. 82° 02' W., 99.86 meters to point 3; thence N. 8° 56' E., 71.33 meters to point 4; thence N. 86° 37' E., 104.46 meters to the point of beginning; containing an area of square meters. All points referred to are indicated on the plan and marked on the ground by Old Points; bearings true; date of the cadastral survey, April 1925—March 1937.

Lot 278
Pantukan Cadastre, Case 1

A parcel of land (Lot 278 of the cadastral survey of Pantukan, L.R.C. Cad. Record No. ———), situated in the Municipality of Pantukan, Province of Davao. Bounded on the E., along line 1-2, by Lot 280, Pantukan Cad.; on the S., W., SW., and S., along line 2-3-4-5-6-7-8-9-10-11-12, by Bingga Creek; on the W., along line 12-13, by Lot 1565; on the N., along line 13-14, by Lot 1828; and on the E., along line 14-1, by Lot 304, all of Pantukan Cad. Beginning at a point marked 1 on plan, being S. 67° 35' W., 364.68 meters from B.L.L.M. 2, Pantukan Cad., thence S. 3° 21' E., 66.90 meters to point 2; thence S. 79° 02' W., 20.50 meters to point 3; thence N. 5° 48' E., 33.67 meters to point 4; thence N. 71° 30' W., 27.55 meters to point 5; thence S. 77° 07' W., 22.19 meters to point C; thence S. 58° 22' W., 17.25 meters to point
