

[PROCLAMATION NO. 20, April 06, 1962]

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 335, SERIES OF 1952, WHICH RESERVED CERTAIN PORTIONS OF THE PUBLIC DOMAIN FOR THE USE OF THE NATIONAL POWER CORPORATION THE AREAS OCCUPIED BY THE MARIA CRISTINA FERTILIZER PLANT AND THE EMPLOYEES HOUSING COMPOUND SITUATED IN ILIGAN CITY AND DECLARING THE SAME OPEN TO DISPOSITION UNDER THE PROVISIONS OF THE PUBLIC LAND ACT

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of sections 83 and 88 of Commonwealth Act No. 141, as amended, I, Diosdado Macapagal, President of the Philippines, do hereby exclude from the operation of Proclamation No. 335, series of 1952, which reserved certain portions of the public domain for the use of the National Power Corporation situated in Iligan City, certain areas occupied by the Maria Cristina Fertilizer Plant and the Employees Housing Compound and declare the same open to disposition under the provisions of the said Act, which parcels of land are more particularly described as follows:

Lot 1
Sgs-1440-D

A parcel of land (Lot 1 is shown, on plan Sgs-1440-D), situated in the District of Buru-un, Iligan City. Bounded on the SE., along lines 1-2-3-4-5, by National Highway; on the SW., along line 5-6, by portion of lot 2043) of Iligan Cadastre (Portion, lot 14, Ir-1028); on the NW., along lines 6-7-8-9-10-11-12, by Portion of lot 2042 of Iligan Cadastre (Portion, lot 29, Ir-1028); on the N. and NE., along lines 12-13-14-15-16-17, by Numucan River; and on the SE., along, line 17-1, by portion of lot 2043 of Iligan Cadastre (Portion lot 14, Ir-1028). Beginning at a point marked 1 on plan, being S. 54° 06' W., 4,500.60 meters from B.L.L.M. 1, Iligan Cadastre; thence N. 87° 18' W., 37.93 meters to point 2; thence S. 63° 12' W., 386.96 meters to point 3; thence S. 63° 19' W., 47.26 meters to point 4; thence S. 65° 54' W., 240.00 meters to point 5; thence N. 29° 54' W., 140.28 meters to point 6; thence N. 62° 27' E., 102.00 meters to point 7; thence N. 34° 16' E., 86.71 meters to point 8; thence N. 53° 06' E., 273.32 meters to point 9; thence N. 50° 54' E., 67.93 meters to point 10; thence N. 60° 51' E., 103.32 meters to point 11; thence N. 3° 30' E., 19.82 meters to point 12; thence N. 82° WE., 100.84 meters to point 13; thence S. 55° 50' E., 59.00 meters to point 14; thence S. 49° 30' E., 45.88 meters to point 15; thence S. 29° 21' E., 62.47 meters to point 16; thence S. 33° 27' E., 105.00 meter's to point 17; thence S. 60° 21' W., 66.17 meters to point of beginning, containing an area of 167,157 square meters. Cyl. Conc. Mons., and the rest by Old Stakes. Bearings true, date of the survey,

July 17-22, 1961, and that of the approval Nov. 2, 1961.

Lot 2

Sgs-1440-D

A parcel of land (Lot 2 as shown on plan Sgs-1440-D), situated in the District of Buru-un, City of Iligan. Bounded on the SW., along line 1-2, by portion of Lot 2034 of Iligan Cadastre (portion, Lot 13, Ir-1028); on the NW., along lines 2-3-4-5, by National Highway; and on the NE. and SE., along lines 5-6-1, by portion of lot 2034 of Iligan Cadastre (Portion, lot 13, Ir-1208). Beginning at a point marked 1 on plan, being S. 55° 24' W., 6,080.00 meters from B.L.L.M. 1, Iligan Cadastre; thence N. 31° 29' W., 72.00 meters to point 2; thence N. 58° 31' E., 193.93 meters to point 3; thence N. 36° 5.3' E., 82.67 meters to point 4; thence N. 58° 36' E., 125.00 meters to point 5; thence S. 31° 24' E., 104.00 meters to point 6; thence S. 58° 46' W., 395.60 to the point of beginning, containing an area of 33,793 square meters. Lot 3

A parcel of land (Lot 3 as shown on plan Sgs-1440-D), situated in the District of Buru-uan, Iligan City. Bounded on the SE., along lines 1-2-3 by National Highway; on the SW., along line 3-4, by portion of Lot 2043 on Iligan Cadastre (Portion, lot 14, Ir-1028; on the NW., along lines 4-5-6-7-8-1, by portion of lot 2042 of Iligan Cadastre (Portion lot 29, Ir-1028), on the NE., along line 8-9, by portion of lot 2043, of Iligan Cadastre (Portion, lot 14, Ir-1028); and on the SE., along line 9-1, by National Highway. Beginning at a point marked 1 on plan, being S. 56° 25' W., 5,802.14 meters from B.L.L.M. 1, Iligan Cadastre; thence S. 37° 16' W. 80.97 meters to point 2; thence S. 58° 32' W., 191.91 meters to point 3; thence N. 43° 54' W., 20.33 meters to point 4; thence N. 56° 17' E., 40.00 meters to point 5; thence No. 46° 31' E., 184.31 meters to point 6; thence N. 53° 29' E., 11.93 meters to point 7; thence N. 52° 14' E., 164,00 meters to point 8; thence S. 33° 22' E., 48.96 meters to point 9; thence S. 58° 17' W., 125.00 meters to the point of beginning, containing an area of 15,478 square meters.
