

[PROCLAMATION NO. 475, January 15, 1958]

**RESERVING FOR MILITARY PURPOSES A PORTION OF THE
PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF
PASUQUIN, PROVINCE OF ILOCOS NORTE**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provision of section 88 of Commonwealth Act No. 141, as amended, I, Carlos P. Garcia, President of the Philippines, do hereby withdraw from sale or settlement and reserve for military purposes, under the administration of the Chief of Staff of the Armed Forces, subject to private rights, if any there be, a certain parcel of the public domain situated in the municipality of Pasuquin, province of Ilocos Norte, particularly described in A. M. S. 8712, First Edition (AMS 1) 1944, sheet 3266 II, Pasuquin, Ilocos Norte, to wit:

Beginning at a point marked 1 on plan AMC, 8713, First Edition (AMS 1) 1944, sheet 3266 II, equivalent to corner 56 of Plan of Provincial reservation, Metropolitan Water Works dated 18 August 1931, hearing S. 33° W., approximately 2.5 km. more or less from Mon. MHM-25; thence N. 45° 07' R., 389.08 meters to point 2, equivalent to corner 57 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 41° 55' R., 437.89 meters to point 3; equivalent to corner 58 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 46° 42' R., 354.27 meters to point 4, equivalent to corner 59 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 47° 10' R., 365.58 meters to point 5, equivalent to corner 60 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 65° 24' R., 285.48 meters to point 6, equivalent to corner 61 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 63° 11' R., 330.61 meters to point 7, equivalent to corner 62 of Plan, of Provincial Reservation, Metropolitan Water Works; thence N. 72° 32' R. 351.91 meters to point 8; thence equivalent to corner 63 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 59° 54' E., 375.05 meters to point 9, equivalent to corner 64 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 74° 16' E., 494.22 meters to point 10, equivalent to corner 65 of Plan of Provincial Reservation, Metropolitan Water Works; thence S. 53° 47' E., 463.19 meters to point 11, equivalent to corner 66 of Plan of Provincial Reservation, Metropolitan Water Works; thence S. 66° 13' E., 600.10 meters to point 12, equivalent to corner 67 of Plan of Provincial Reservation, Metropolitan Water Works; thence N. 74° 28' E., 210 meters to point 13; thence due south, 1,330 meters to point 14 (Long. 120° 40' 00" Lot 18° 24' 00") ; thence due west, 2,500 meters to point 1 or corner 56 the point of beginning. Containing an area 423.7557 hectares more or less.
