### [ PROCLAMATION NO. 370, February 17, 1953 ]

# RESERVING FOR CERTAIN PUBLIC PURPOSES CERTAIN PARCELS OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF MIDSAYAP, PROVINCE OF COTABATO, ISLAND OF MINDANAO.
