

**[ PROCLAMATION NO. 397, June 16, 1953 ]**

**EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 610,  
DATED AUGUST 29, 1940 AND RESERVING FOR CERTAIN PUBLIC  
PURPOSES CERTAIN PARCELS OF LAND EMBRACED THEREIN  
SITUATED IN THE POBLACION, MUNICIPALITY OF ROXAS,  
PROVINCE OF ISABELA, ISLAND OF LUZON.**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 83 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation of Proclamation No. 610, dated August 29, 1940, and reserve for certain public purposes as indicated hereunder, under the administration of the Municipality of Roxas, subject to private rights, if any there be, certain parcels of land embraced therein situated in the poblacion, Municipality of Roxas, Province of Isabela, Island of Luzon, and more particularly described as follows:

*Lot 455, Gamu PLS-62*  
(school site)

A parcel of land (lot 455 of Gamu PLS-62), situated in the poblacion, municipality of Roxas, Province of Isabela. Bounded on the NE., SE. and SW., by road; and on the NW., by road and lot 7454 of Gamu PLS-62. Beginning at a point marked 1 on plan, being N. 67° 20' E., 635.54 m. from B.L.L.M. 114, Gamu PLS-62, thence S. 77° 53' E., 95.32 m. to point 2; thence S, 11° 52' W., 191.98 m. to point 3; thence N. 80° 38' W., 121.93 m. to point 4; thence N. 19° 80' E., 160.92 m. to point 5; thence N. 19° 30' E., 38.54 m. to the point of beginning; containing an area of 21,120 square meters, more or less. All points referred to are indicated on the plan and are marked on the ground by B.L. concrete monuments; bearings true; declination 0° 44' E.; date of survey, Nov. 28, 1938-May 20, 1941 and that of the approval, Feb. 20, 1950.

*Lot 7802, Gamu PLS-62,*  
(market site)

A parcel of land (lot 7802 of Gamu PLS-62), situated in the poblacion, municipality of Roxas, Province of Isabela. Bounded on the NE., SE., SW. and NW., by Road. Beginning at a point marked on plan, being N. 5° 08' E., 623.78 m. from B.L.L.M. 113, Gamu PLS-62, thence N. 16° 35' W., 135.15 m. to point 2; thence N. 73° 36' E., 100.14 m. to point 3; thence S. 16° 39' E., 134.78 m. to point 4; thence S. 73° 23' W., 100.37 m. to the point of beginning; containing an area of 13,525 square meters, more or less. All points referred to are indicated on the plan and are marked on the ground by B.L. concrete monuments; bearings true; declination 0° 44' E., date of survey, Nov. 28, 1938—May 20, 1941 and that of the approval, Feb. 20, 1950.
