## [ PROCLAMATION NO. 433, December 23, 1953 ]

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 414, SERIES OF 1931, A CERTAIN PORTION OF THE LAND EMBRACED THEREIN SITUATED IN THE MUNICIPALITY OF KAPALONG, PROVINCE OF DAVAO, ISLAND OF MINDANAO, AND DECLARING THE SAME OPEN TO DISPOSITION UNDER THE PROVISIONS OF THE PUBLIC LAND ACT.

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 88 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation, of Proclamation No. 414, series of 1931, a certain portion of the land embraced therein situated in the municipality of Kapalong, Province of Davao, Island of Mindanao, and declare the same open to disposition under the provisions of said Act, which portion, of land is more particularly described in the Bureau of Lands plan SC-V-12067-D as follows, to wit:
