

**[ PROCLAMATION NO. 448, December 23, 1953 ]**

**EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 251,  
CURRENT SERIES, AND DECLARING OPEN TO DISPOSITION  
UNDER THE PROVISIONS OF THE PUBLIC LAND ACT A CERTAIN  
PARCEL OF LAND SITUATED IN LA PAZ, ILOILO CITY**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of Sections 83 and 88 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation of Proclamation No. 251, current-series, and declare open to disposition under the provisions of said Act, a parcel of land situated in La Paz, Iloilo City, and more particularly described as follows, to wit:

“Lot 3  
Rlla-V-56-D  
(The Shell Company of the  
P. I., Ltd.)

A parcel of land (Lot 5 of plan Rlla-V-56-D), situated in the District of La Paz, City of Iloilo. Bounded on the SE., by Public land; on the SW., by Lot 1-A of plan 11-7000; and on the NW., by Lot 2 of plan Rlla-V-56-D. Beginning at a point marked “1” on plan, being S. 33 deg. 11’ E., 1192.11 m. from B.B.M. 57, Iloilo Cad. 21,

thence N.	54 deg.	30’ E.,	78.48 m.	to	point “2”;
thence S.	11 deg.	25’ W.,	44.00 m.	to	point “3”;
thence S.	10 deg.	16’ W.,	38.74 m.	to	point “4”;
thence N.	53 deg.	32’ W.,	60.03 m.	to	to the point of

beginning; containing an area of TWO THOUSAND TWO HUNDRED TWENTY THREE (2,223) Square Meters, more or less. All points referred to are indicated on the plan and are marked on the ground as follows: point “1” by old corner and the rest, by P.L.S. Cyl. Conc. Mons.; bearings true; declination 1 deg. 36’ E.; date of survey, July 27, 1951.

NOTE: Lot 3 = an additional lot 6166 of Iloilo Cad. 21, formerly shore of Iloilo Strait.”
