

[PROCLAMATION NO. 462, December 23, 1953]

**RESERVING FOR PARK AND PLAYGROUND SITE PURPOSES A
CERTAIN PARCEL OF THE PUBLIC DOMAIN SITUATED IN THE
DISTRICT OF CALINAN, CITY OF DAVAO**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of Section 83 of Commonwealth Act No. 141, as amended, I hereby withdraw from sale or settlement and reserve for park and playground site purposes under the administration of the City of Davao, subject to private rights, if any there be, a certain parcel of the public domain situated in the District of Calinan, City of Davao, and more particularly described in the Bureau of Lands Plan Bsd-10815, it wit:

“LOT 502-B-1
Bsd-10815
(The City Gov’t. of Davao –
Calinan Park & Playgrounds)

“A PARCEL OF LAND (Lot 502-B-1 of the subdivision plan Bsd-10815, being a portion of Lot 502-B described on plan Psd-9412, G.L.R.O. Record No. _____), situated in the City of Davao. Bounded on the N., by Lot 500, Guianga Cad.; on the E. and S., by Lot. 502-B-2 of the subdivision plan; and on the W., by Lot 502-A of plan Psd-9412. Beginning at a point marked “1” on plan, being N. 79 deg. 11’ W., 185.97 m. from B.L.L.M. 17, Guianga Cad. 174,

thence S.	79 deg.	11’ E.,	131.34 m.	to	point “2”;
thence S.	22 deg.	43’ W.,	122.00 m.	to	point “3”;
thence N.	67 deg.	17’ W.,	97.86 m.	to	point “4”;
thence N.	4 deg.	49’ E.,	99.75 m.	to	the point of

beginning; containing an area of TWELVE THOUSAND FOUR HUNDRED EIGHTY THREE (12,483) Square Meters, more or less. All points referred to are indicated on the plan and are marked on the ground by B.P.W./D.C.S.M. Conc. Mons.; bearings true; declination 2 deg. 00’ E.; date of the subdivision survey, July 10, 1952.”
