

[PROCLAMATION NO. 246, April 02, 1951]

**EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 414,
SERIES OF 1931, AND DECLARING OPEN TO DISPOSITION
UNDER THE PROVISIONS OF THE PUBLIC LAND ACT A PARCEL
OF LAND LOCATED AT TAGUM, DAVAO.**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 83 and 88 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation of Proclamation No. 414, series of 1931, and declare open to disposition under the provisions of the same Act, a parcel of land located at Tagum, Davao and more particularly described as follows:

A parcel of land (partial subdivision plan Psd-22516, being a portion of lot 4710 of the Cadastral survey of Tagum, G.L.R.O. cadastral Record No.—), situated in the barrio of Ising, municipal district of Tagum, Province of Davao. Bounded on the N., by portion of lot 4710 (Davao Penal Colony); on the NE., by national highway (60.00 m. wide); on the S., by lot 4850, of Tagum cadastre; and on the W., by portion of lot 4710 (Davao Penal Colony).
