

[PROCLAMATION NO. 247, April 02, 1951]

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 414, SERIES OF 1931, A CERTAIN PORTION OF THE LAND EMBRACED THEREIN SITUATED IN THE MUNICIPALITY OF TAGUM, PROVINCE OF DAVAO, ISLAND OF MINDANAO, AND DECLARING THE SAME OPEN TO DISPOSITION UNDER THE PUBLIC LAND ACT.

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 88 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation of Proclamation No. 414, series of 1931, a certain portion of the land embraced therein situated in the municipality of Tagum, Province of Davao, Island of Mindanao, and declare the same open to disposition under the provisions of the Public Land Act, which portion of land is more particularly described in the Bureau of Lands plan Sc-3029, to wit:

All points referred to are indicated on the plan and are marked on the ground as follows: points 9 to 27 inclusive by old P.L.S. S. concrete monuments, points 28 to 40 inclusive by old B.L. concrete monuments and the rest by P.L.S. cylindrical concrete monuments.
