## [ PROCLAMATION NO. 114, January 04, 1949 ]

## RESERVING FOR MARKET, SLAUGHTER HOUSE AND PARK SITES PURPOSES CERTAIN PARCELS OF THE PUBLIC DOMAIN LOCATED IN THE MUNICIPALITY OF MALABON, PROVINCE OF RIZAL, ISLAND OF LUZON

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 83 of Commonwealth Act No. 141, as amended, I hereby withdraw from sale or settlement and reserve for market, slaughter house and park sites purposes, under the administration of the municipality of Malabon, subject to private rights, if any there be, certain parcels of the public domain located in the municipality of Malabon, Province of Rizal, and more particularly described in the Bureau of Lands Plan Swo-21985, to wit:
