

[PROCLAMATION NO. 132, June 17, 1949]

EXCLUDING FROM THE OPERATION OF THE EXECUTIVE ORDER OF THE PRESIDENT OF THE UNITED STATES DATED FEBRUARY 15, 1904, AND PROCLAMATION NO. 5, SERIES OF 1909, OF THE THEN GOVERNOR GENERAL OF THE PHILIPPINES, AND PRESERVING FOR TOWNSITE PURPOSES A CERTAIN PARCEL OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF PARANG, PROVINCE OF COTABATO, ISLAND OF MINDANAO.

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of section 72 of Commonwealth Act No. 141, as amended, I hereby exclude from the operation of the Executive Order of the President of the United States dated February 15, 1904, and Proclamation No. 5, series of 1909, of the then Governor General of the Philippines, and reserve for townsite purposes, subject to the disposition under Chapter XI of the same Act and to private rights, if any there be, a certain parcel of the public domain, situated in the municipality of Parang, Province of Cotabato, Island of Mindanao, and more particularly described in the Bureau of Lands plan Tb-102, to wit:

"A parcel of land (as shown on plan Tb-102), situated in the municipality of Parang, Province of Cotabato. Bounded on the NW., NE., and SE., by Parang Military Reservation (11-6280 portion); on the S., by national road 20.00 m. wide and Polloc Harbor; on the SW., by public land, property of Andres Fernandez and Nitnan River (as per H-146582); and on the W., by Polloc Harbor. Beginning at a point marked 1 on plan, being N. 72° 17' E., 7,299.17 m. from triangulation station Red C. & G.
