MEMORANDUM OF UNDERSTANDING BETWEEN THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES AND THE GOVERNMENT OF AUSTRALIA RELATING TO THE TREE ESTABLISHMENT TECHNOLOGIES IN THE PHILIPPINES

1. GENERAL

- 1.1 This MEMORANDUM expresses the understandings of the Government of the Republic of the Philippines and the Government of Australia concerning the responsibilities and contributions respectively of the two Governments with regard to the implementation of the ACIAR Project No. 9208 TREE ESTABLISHMENT TECHNOLOGIES IN THE PHILIPPINES.
- 1.2 The project aims to test promising fast-growing tree provenances identified by previous ACIAR projects, develop management techniques for the nursery which establishment effective microbial-plant symbioses and produce hardened, vigorous plants with minimum rooting material for out-planting. It will also develop adequate nutrition for rapid plant growth. The project is further described in Attachment 1 of this Memorandum of Understanding.

2. DEFINITIONS

In This Memorandum:

"Australian institutions, firms and organisations" means Australian institutions, firms or organisations engaged in the project;

"Australian personnel" means Australian nationals or permanent residents or other persons who are not nationals or permanent residents of the Philippines, who are working in the Philippines on the project and whose salaries or other costs are funded from the contribution of the Government of Australia to the project;

"dependant/dependent" means the spouse or unmarried minor children of a member of the Australian personnel or any other person recognised by the two Governments as a dependant/dependent of a member of the Australian personnel;

"professional and technical material" means equipment, motor vehicles, and other goods imported by members of the Australian personnel or Australian institutions, firms and organisations for their professional use in carrying out their assigned duties under the project and paid for from funds provided by the Government of Australia;

"project supplies" means equipment, material and other goods supplied for the execution of the project, the cost of which is funded from the contribution of the Government of Australia to the project;

"services" means services performed by individuals or by general professional partnerships registered in the Philippines as detailed in Attachment 1; and

"personal and household effects" means equipment, motor vehicles and other goods imported by Australian personnel or Australian institutions, firms and organisations for the personal use of Australian personnel and their dependents while engaged in the project.

3. COORDINATING AUTHORITIES AND IMPLEMENTING AGENCIES

- 3.1 Each Government will implement the research project through respective Coordinating authorities.
- 3.2 The Australian Centre for International Agricultural Research, hereinafter referred to as ACIAR, will be the Australian Co-ordinating Authority. The Department of Foreign Affairs, hereinafter referred to as the DFA, will be the Philippine Co-ordinating Authority.
- 3.3 Under the terms of this Memorandum of Understanding, ACIAR nominates the Queensland Department of Primary Industries' Forest Research Institute, Gympie, hereinafter referred to as QDPI, to carry out the project on its behalf, and the DFA nominates the College of Forestry and the National Institute of Biotechnology and Applied Microbiology (BIOTECH), University of the Philippines at Los Banos hereinafter referred to as (UPLB), Department of Environment and Natural Resources (DENR) Region 7 and 8, Ecosystems Research and Development Bureau (ERDB) and Visayas State College of Agriculture (VISCA) to carry out the project on its behalf, as described and detailed in Attachment 1.

4. CONTRIBUTIONS

- 4.1 The contributions of the Government of the Republic of the Philippines and the Government of Australia as described in Attachment I are estimated to value Three Hundred and eighty two thousand five hundred and twenty dollars (AUD \$ 382,500) and One Hundred and ninety one thousand nine hundred and twenty dollars (AUD \$ 191,920) respectively. The financial contribution of the Government of the Republic of the Philippines will be subject to its annual Congressional appropriations. The financial contribution of the Government of Australia will be subject to the normal annual parliamentary approval of appropriations.
- 4.2 Further to the estimated contributions above, additional funds will be provided by the Government of the Republic of the Philippines for payment of taxes incurred through implementation of the project.

5. PERSONNEL

- 5.1 The Government of the Philippines and the Government of Australia as described will provide personnel possessing the competence required for the project, including Australian and Philippine project leaders. The project leaders will have responsibility for effective implementation in their respective countries.
- 5.2 Personnel composition in QDPI and UPLB are as described in Attachment

6. IMPLEMENTATION, MONITORING AND REVIEW

6.1 Project implementation will follow the schedule specified in Attachment 1. The project leaders will provide a yearly progress report to ACIAR, copies of which will be forwarded to the DFA.
