Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 3 of Ordinance No. 8362 is hereby amended to increase the value of the Birthday Gift entitled to the senior citizens of the City of Manila, to read as follows:

"SEC. 3. BIRTHDAY GIFT. – All Senior Citizens or elderly shall be granted a yearly Birthday Gift, in the amount of **Five Hundred Pesos (PhP. 500.00)**, to be given in cash or in kind or a combination thereof."
