

[PROCLAMATION NO. 377, March 13, 1953]

**EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 20,
SERIES OF 1921, CERTAIN PARCELS OF LAND EMBRACED
THEREIN AND RESERVING THE SAME FOR CAPITOL SITE
PURPOSES OF THE PROVINCE OF NUEVA ECIJA, SITUATED IN
THE MUNICIPALITY OF BONGABON, PROVINCE OF NUEVA ECIJA,
ISLAND OF LUZON.**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and by virtue of the powers vested in me by section 64 (e) of the Revised Administrative Code, I hereby exclude from the operation of Proclamation No. 20, series of 1921, and reserve for capitol site purposes of the Province of Nueva Ecija, subject to private rights, if any there be, certain parcels of land embraced therein, situated in the municipality of Bongabon, Province of Nueva Ecija, Island of Luzon, and more particularly described as follows, to wit:

"Lot 1-A, Bsd-10908, (capitol site)

A parcel of land (lot 1-A of the subdivision plan Bsd-10908, being a portion of lot 1 described on plan In-162, G.L.R.O. record No. ———), situated in the barrio of Atate, municipality of Bongabon, Province of Nueva Ecija. Bounded on the NE., by lot 1-B of the subdivision plan; on the E., SE., and SW., by public land; and on the NW., by provincial road. Beginning at a point marked 1 on plan, being N. 74° 35' E., 18,205.41 m. from B.L.L.M. No. 1, Cabanatuan City, thence S. 63° 21' W., 2,250.15 m. to point 2; thence S. 37° 30' W., 514.22 m. to point 3; thence N. 63° 35' W., 1,121.68 m. to point 4; thence N. 67° 08' W., 2,970.22 m. to point 5; thence N. 36° 08' E., 429.79 m. to point 6; thence N. 70° 14' E., 655.11 m. to point 7; thence N. 83° 49' E., 321.14 m. to point 8; thence N. 41° 59' E., 2,085.05 m. to point 9; thence S. 73° 02' E., 3,388.38 m. to point 10; thence S. 9° 44' E., 1,421 m. to the point of beginning; containing an area of 12,856,578 square meters, more or less. All points referred to are indicated on the plan and are marked on- the ground as follows: Points 1, 2, 5, 8, and 9, by old B. L. cylindrical concrete monuments; point 10, by B. L. cylindrical concrete monuments; and the rest, by Old Corners; bearings true; declination 0° 30' E.; date of the subdivision survey, January 7-17, 1952."

"Lot 2-A, Bsd-10908, (capitol site)

A parcel of land (lot 2-A of the subdivision plan Bsd-10908, being a portion of lot 2 described on plan .In-162, G.L.R.O. record. No. ———), situated in the barrio of Atate, municipality of Bongabon, Province of Nueva Ecija. Bounded on the NE., by Pampanga River and lot 2-B of the subdivision plan; on the SW., by provincial road; on the SW., by property of Jose Nava; and on the NW., by property of Eduardo Dulay and Pampanga River.

Beginning at a point marked 1 on plan, being N. 62° 45' E., 15,816.78 m. from B.L.L.M. No. 1, Cabanatuan City, thence S. 41° 59' W., 2,076.29 m. to point 2;
