1. These Regulations may be cited as the Customs (Offices and Stations) Regulations.

Customs offices and customs stations generally

2. The following places shall be customs offices and customs stations generally:— (1) any premises licensed under the Act, other than Part VIII thereof; (2) any premises in which duty exempted goods are kept;

(3) any factory using dutiable raw materials for manufacture;

(4) any premises licensed under Part XIV or XIVA of the Goods and Services Tax (General) Regulations (Cap. 117A, Rg 1);

(5) any authorised landing pier or place for dutiable goods imported by sea and any place where dutiable exports are permitted to be uplifted by vessels;
