### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 17) ORDER 2010**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 17) Order 2010 and shall come into operation on 4th November 2010.

#### **Declaration of precincts for lift upgrading works**

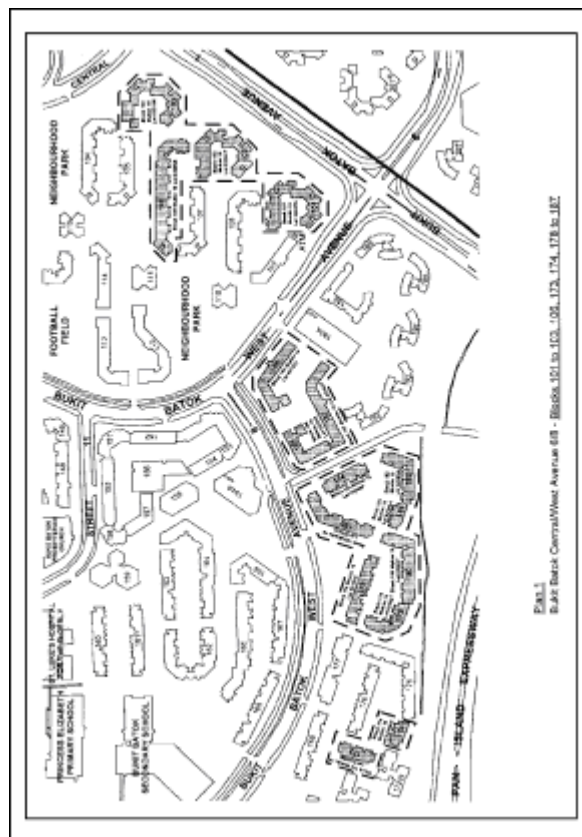
2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Bukit Batok Central/West Avenue 6/8 comprised in Lot numbers 02247A, 02246T, 02310N, 02308X, 02345M, 02346W, 02162K, 02347V and 02348P in Mukim 10 and on which Apartment Blocks 101, 102, 103, 106, 173, 174, 178, 183 and 184 are erected, in Lot number 02352T in Mukim 10 and on which Apartment Blocks 179 and 180 are erected, in Lot number 02353A in Mukim 10 and on which Apartment Blocks 181 and 182 are erected, and in Lot number 02753T in Mukim 10 and on which Apartment Blocks 185, 186 and 187 are erected, and which is more particularly delineated in Plan 1.

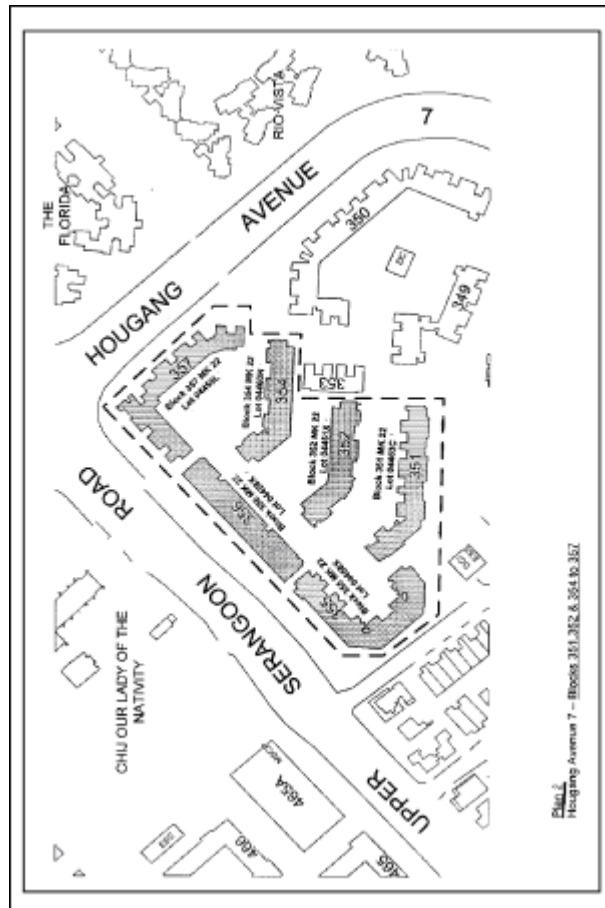
#### BUKIT BATOK CENTRAL/WEST AVENUE 6/8

### PLAN 2

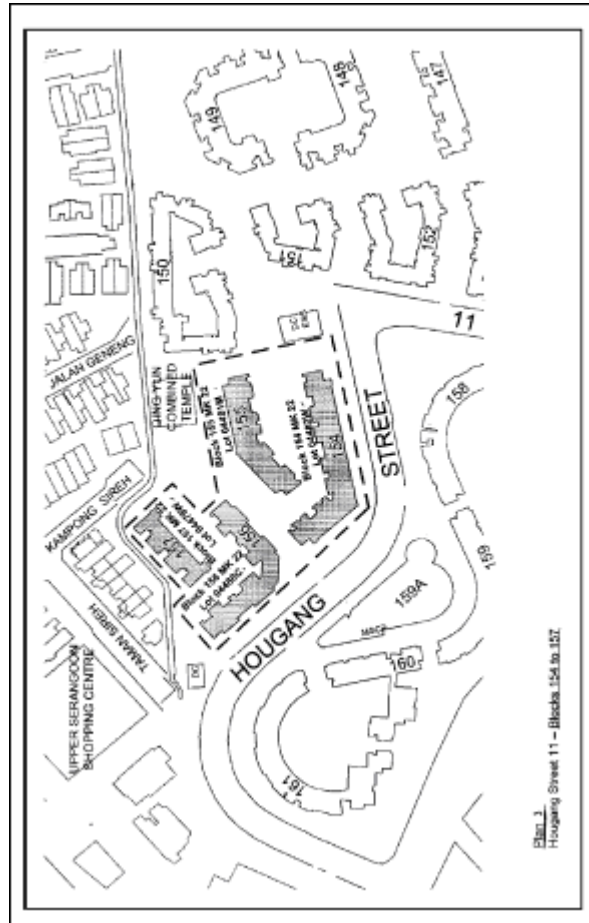
## HOUGANG AVENUE 7
