### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 4) ORDER 2011**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 4) Order 2011 and shall come into operation on 3rd March 2011.

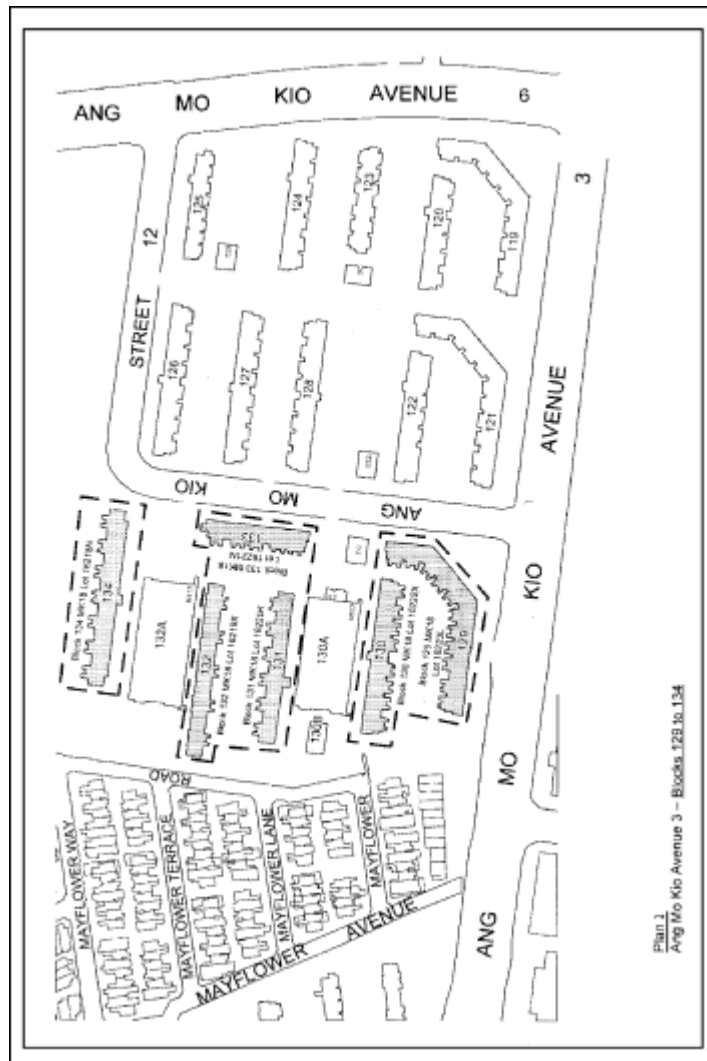
#### **Declaration of precincts for lift upgrading works**

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Ang Mo Kio Avenue 3 comprised in Lot numbers 16223L, 16222X, 16220K, 16219X, 16221N and 16218N in Mukim 18 and on which Apartment Blocks 129, 130, 131, 132, 133 and 134 are erected, and which is more particularly delineated in Plan 1.

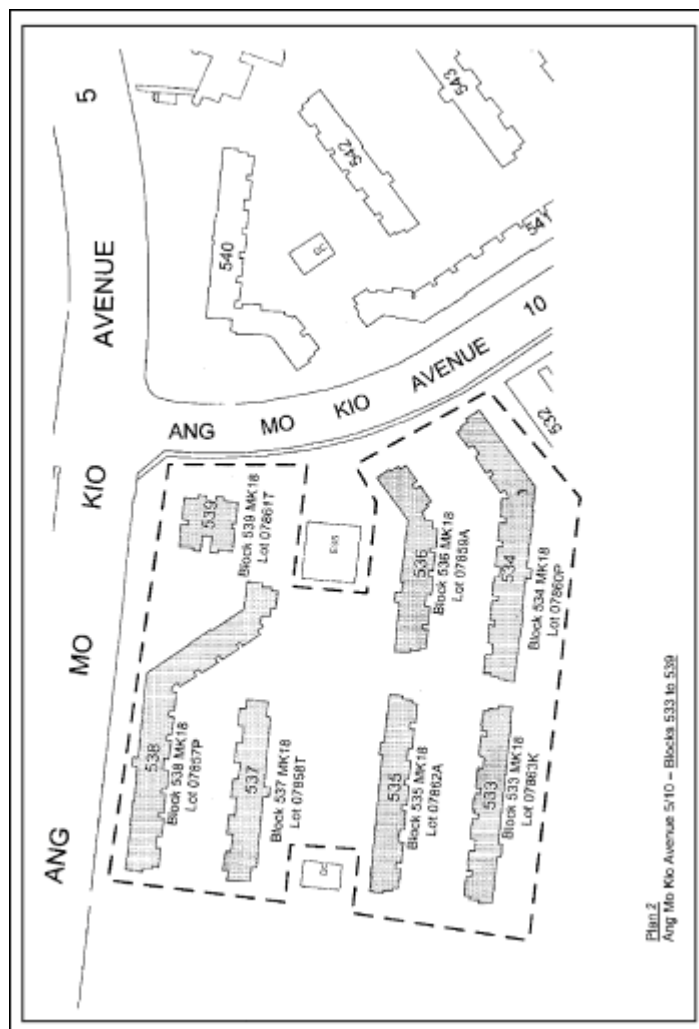
PLAN 1

All that part of the housing estate of the Board at Ang Mo Kio Avenue 5/10 comprised in Lot numbers 07863K, 07860P, 07862A, 07859A, 07858T, 07857P and 07861T in Mukim 18 and on which Apartment Blocks 533, 534, 535, 536, 537, 538 and 539 are erected, and which is more particularly delineated in Plan 2.

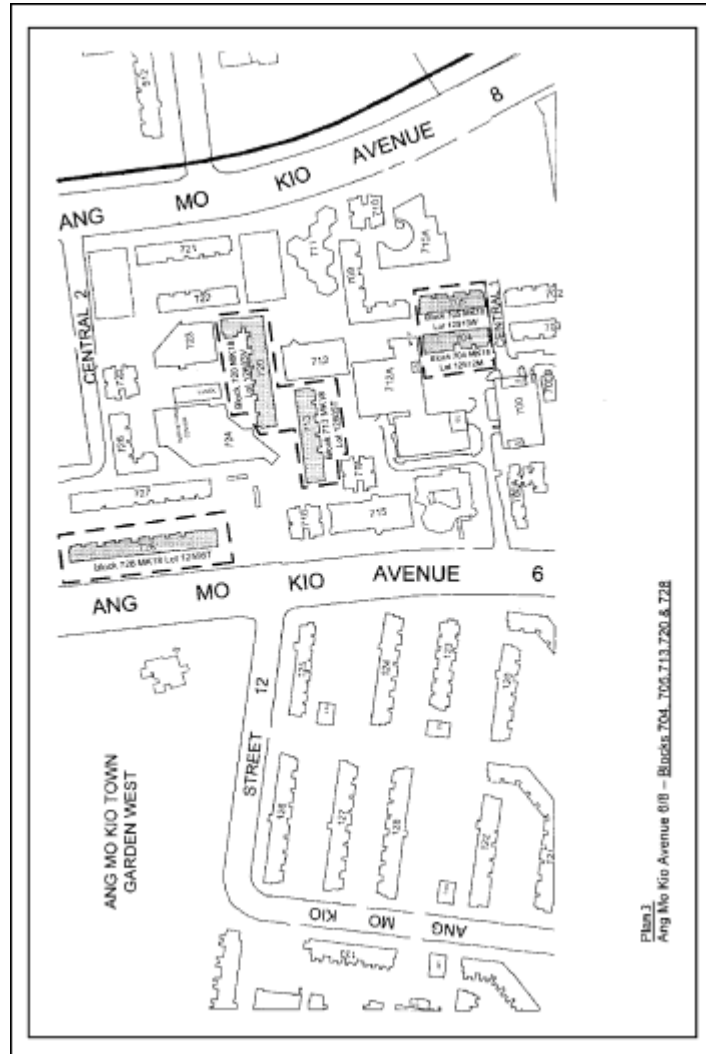
PLAN 2

## ANG MO KIO AVENUE 5/10



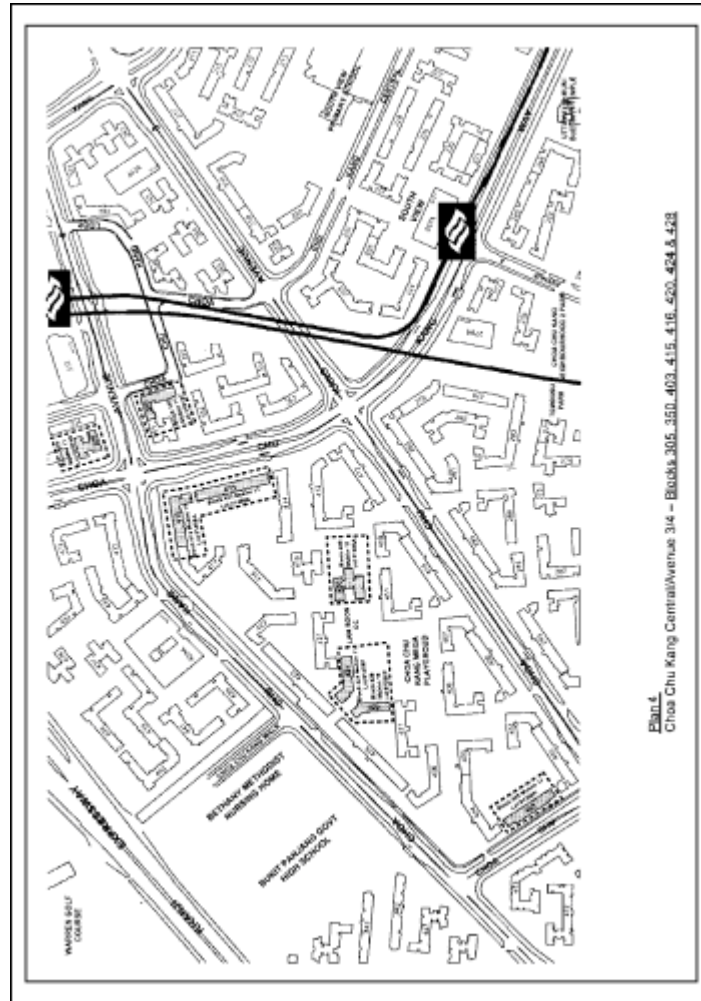
