### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 5) ORDER 2010**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 5) Order 2010 and shall come into operation on 8th April 2010.

#### **Declaration of precincts for lift upgrading works**


2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Chai Chee Drive/Road comprised in Lot numbers 5974K, 5975N, 5973A, 5634L and 5633X in Mukim 27 and on which Apartment Blocks 59, 60, 61, 62 and 63 are erected, and in Lot numbers 2634A, 3156W, 3157V and 3158P in Mukim 28 and on which Apartment Blocks 55, 56, 57 and 58 are erected, and which is more particularly delineated in Plan 1.

CHAI CHEE DRIVE/ROAD




Plan 1

All that part of the housing estate of the Board at Jurong East Street 32 comprised in Lot numbers 3831N, 3823V, 3830K, 3822W, 4002L, 4001X, 4187W, 4186M, 4185C and 4184L in Mukim 5 and on which Apartment Blocks 301, 302, 303, 304, 305, 306, 307, 308, 309 and 310 are erected, and which is more particularly delineated in Plan 2.
