### Precincts for upgrading works


2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in the precincts.

#### ANG MO KIO







#### LORONG LEW LIAN






PLAN 5 TELOK BLANGAH
