A BILL

An Act to establish the Pioneer Generation Fund to provide financial and other support to Singapore's Pioneers and for matters connected therewith.

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows:

PART 1  
PRELIMINARY

**Short title and commencement**

1. This Act may be cited as the Pioneer Generation Fund Act 2014  
5 and shall come into operation on such date as the Minister may, by  
notification in the *Gazette*, appoint.

**Interpretation**

2. In this Act, unless the context otherwise requires —

10 “accounting officer” means a public officer appointed under  
section 9;

“Central Provident Fund” means the Central Provident Fund  
established under the Central Provident Fund Act (Cap. 36);

“disability” means disability that —

15 (a) is attributable to intellectual, psychiatric, sensory or  
physical impairment or a combination of those  
impairments;

(b) is permanent or likely to be permanent; and

(c) results in a substantial need for continuing support in  
daily living activities;

20 “Fund” means the Pioneer Generation Fund established under  
section 4;

“health service” means an activity performed in relation to an  
individual —

25 (a) that is intended or claimed (expressly or otherwise) by  
the individual or the person performing the activity —

(i) to diagnose the individual’s illness or disability;

(ii) to treat the individual’s illness or disability, or  
suspected illness or disability; or

30 (iii) to assess, record, maintain or improve the  
individual’s health; or
