CENTRAL PROVIDENT FUND ACT (CHAPTER 36)

CENTRAL PROVIDENT FUND (SELF-EMPLOYED PERSONS) (AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred by section 77(1) of the Central Provident Fund Act, the Minister for Manpower, after consulting with the Central Provident Fund Board, makes the following Regulations:

Citation and commencement

1. These Regulations are the Central Provident Fund (Self-Employed Persons) (Amendment) Regulations 2020 and come into operation on 1 May 2020.

Amendment of regulation 5

- **2.** Regulation 5(1) of the Central Provident Fund (Self-Employed Persons) Regulations (Rg 25) (called in these Regulations the principal Regulations) is amended
 - (a) by deleting the words "at the following rates:" and substituting the words "at the applicable rate set out in the Second Schedule."; and
 - (b) by deleting sub-paragraphs (a) and (b).

Amendment of regulation 10

3. Regulation 10(3) of the principal Regulations is amended by deleting the words "paragraph (1) or (2) of the Second Schedule, as the case may be" in sub-paragraph (b) and substituting the words "the Second Schedule".

Deletion and substitution of Second Schedule

4. The Second Schedule to the principal Regulations is deleted and the following Schedule substituted therefor:
