#### Citation

**1.** This Notification is the Common Gaming Houses (Exemption) Notification 2017.

## **Exemption**

- **2.**—(1) The Minister exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of
  - (a) the "MBS Festive Draw Series" promotion to be held from 20 January 2017 to 25 December 2017 (both dates inclusive);
  - (b) the draws to be held as part of that promotion at the Main Casino Floor (Level B2M) at Marina Bay Sands in 3 sessions hourly from 8 p.m. to 10 p.m. on the following dates:
    - (i) 28 January 2017 and 29 January 2017;

- (ii) 4 February 2017 and 5 February 2017;
- (iii) 14 April 2017 and 15 April 2017;
- (iv) 30 April 2017 and 1 May 2017;
- (v) 9 May 2017 and 10 May 2017;
- (vi) 25 June 2017 and 26 June 2017;
- (vii) 8 August 2017 and 9 August 2017;
- (viii) 1 September 2017 and 2 September 2017;
  - (ix) 17 October 2017 and 18 October 2017;
  - (x) 24 December 2017 and 25 December 2017; and
- (c) the "Consolation Lucky Draw" to be held as part of that promotion at the Main Casino Floor (Level B2M) at Marina Bay Sands at 10.15 p.m. on the following dates:
  - (i) 28 January 2017 and 29 January 2017;
  - (ii) 4 February 2017 and 5 February 2017;
  - (iii) 14 April 2017 and 15 April 2017;
  - (iv) 30 April 2017 and 1 May 2017;
  - (v) 9 May 2017 and 10 May 2017;
  - (vi) 25 June 2017 and 26 June 2017;
  - (vii) 8 August 2017 and 9 August 2017;
  - (viii) 1 September 2017 and 2 September 2017;
    - (ix) 17 October 2017 and 18 October 2017;
    - (x) 24 December 2017 and 25 December 2017.
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.
