MEDICAL AND ELDERLY CARE ENDOWMENT SCHEMES ACT (CHAPTER 173A)

MEDICAL AND ELDERLY CARE ENDOWMENT SCHEMES (MEDIFUND COMMITTEES) (AMENDMENT NO. 11) ORDER 2017

In exercise of the powers conferred by section 14 of the Medical and Elderly Care Endowment Schemes Act, the Minister for Health makes the following Order:

Citation and commencement

- 1.—(1) This Order is the Medical and Elderly Care Endowment Schemes (Medifund Committees) (Amendment No. 11) Order 2017 and, except for paragraphs 2 and 3(1), is deemed to have come into operation on 26 September 2017.
- (2) Paragraph 2(d) is deemed to have come into operation on 1 May 2016.
- (3) Paragraph 2(a) is deemed to have come into operation on 10 January 2017.
- (4) Paragraph 2(c) is deemed to have come into operation on 24 July 2017.
- (5) Paragraphs 2(b) is deemed to have come into operation on 5 September 2017.
- (6) Paragraphs 2(e) and 3(1) are deemed to have come into operation on 18 September 2017.
