**ENVIRONMENTAL PUBLIC HEALTH ACT  
(CHAPTER 95)**

**ENVIRONMENTAL PUBLIC HEALTH  
(PUBLIC CLEANSING) (AMENDMENT)  
REGULATIONS 2013**

In exercise of the powers conferred by section 111 of the Environmental Public Health Act, the National Environment Agency, with the approval of the Minister for the Environment and Water Resources, hereby makes the following Regulations:

**Citation and commencement**

**1.**—(1) These Regulations may be cited as the Environmental Public Health (Public Cleansing) (Amendment) Regulations 2013 and shall, with the exception of regulations 2(c) and (d) and 4, come into operation on 1st April 2013.

(2) Regulations 2(c) and (d) and 4 shall come into operation on 1st July 2013.

**Amendment of Second Schedule**

**2.** The Second Schedule to the Environmental Public Health (Public Cleansing) Regulations (Rg 3) (referred to in these Regulations as the principal Regulations) is amended —

- (a) by deleting the words “Colex Holdings Ltd.” in paragraph 3 and substituting the words “Colex Environmental Pte. Ltd.”;
- (b) by deleting sub-paragraphs (2) and (3) of paragraph 3 and substituting the following sub-paragraphs:

“(2) Non-domestic premises where daily quantity of refuse collected and removed —

- (3) Hawker stalls, including stalls in public markets and markets managed by Statutory Boards, and those operating on temporary permits \$39.59 per stall.”;
- (c) by deleting the words “SembWaste Pte Ltd.” in paragraph 4 and substituting the words “Veolia ES Singapore Pte. Ltd.”; and
- (d) by deleting sub-paragraphs (2) and (3) of paragraph 4 and substituting the following sub-paragraphs:
